- ❖ If the pet shall in any form become ill or if the state of the animals health otherwise requires attention, Yeager Dog Grooming & Boarding at its sole discretion, is authorized to engage the services of the veterinarian provided in this contract. If listed veterinarian is unavailable, Yeager Dog Grooming & Boarding has the right to provide in-house veterinary services or arrange the animal up to \$_____ (Amount/Initials) at the pet owner's expense.

- ❖ Owner will pay all costs and charges for special services requested, and provide updated vaccination records from your vet before boarding date.
- ❖ Owner represents that the pet has not been exposed to rabies or distemper within 30 days prior to boarding.
- ❖ Owner specifically represents that they lawfully own the pet listed in this contract to the best of their knowledge.
- ❖ Owner will be held solely responsible for any and all acts or behavior, including aggression, which takes place during boarding.
- ❖ Owner understands that the pet shall not leave the kennel until all fees and charges are satisfied in full.
- ❖ If the pet is left at the facility, with no contact by owner, after the agreed upon date, Yeager Dog Grooming & Boarding has sole right to surrender the pet to Calhoun County Animal Center after 7 days.
